If you have completed the Public Comment Registration form, you will receive an email the day before the meeting with instructions for providing virtual public comment. Public comment is limited to three minutes. Each speaker providing oral public comments virtually must ensure their face is visible and their voice audible to the other participants while they are speaking. Each speaker must state their name and on whose behalf they are speaking (if anyone). If you pre-register to speak and wish to provide a handout before the meeting, please submit an electronic copy in accessible PDF format that will be distributed by HHS staff to TMDP members and State staff. Handouts are limited to two pages (paper size: 8.5" by 11", one side only). Handouts must be emailed to HHSC_TMDP@hhsc.state.tx.us [mailto:HHSC_TMDP@hhsc.state.tx.us] immediately after pre-registering, but no later than 5:00 p.m. Monday, May 2, 2022, and include the name of the person who will be commenting. Staff will not read written comments aloud during the meeting, but comments will be provided to TMDP members and State staff.
