### H. CONSENT ITEM(S)

1. Minutes of August 25, 2025 - Consider approval of the minutes from the August 25, 2025, meeting.

### I. NON-DISCRETIONARY ITEM(S)

This part of the agenda consists of items that are in compliance with all applicable development standards; are not requesting waivers, exceptions, or deviations, and do not require a Public Hearing.

1. SSP25-0004 - Brookview Phase 1B - Consider a request for a Subdivision Site Plan (SSP25-0004- Brookview Phase 1B) to create a residential subdivision. The property is generally located north of Cross Timbers Road east of Canyon Falls Drive.
2. SP22-0014 - Silveron Park Multifamily Lot 7, Block A - Consider a request for a Site Plan (SP22-0014 – Silveron Park Multifamily Lot 7, Block A) to develop three multifamily buildings. The property is generally located south of International Parkway and east of Lakeside Village Boulevard.

#### **J. REGULAR ITEM(S)**

1. SSP25-0003 - Brookview Phase 1A - Consider a request for a Subdivision Site Plan (SSP25-0003- Brookview Phase 1A) to create a residential subdivision with certain exceptions, modifications, and waivers to the Code of Ordinances. The property is generally located north of Cross Timbers Road east of Canyon Falls Drive.
2. RP25-0006 - Flower Mound Family Farmhouse Addition Lots 1R & 2R, Block A - Public Hearing to consider a request for a Replat (RP25-0006 – FM Family Farmhouse Addition, 1R & 2R, Block A) to relocate lot lines between two residential lots with an exception to lot depth pursuant to Section 90-272(a), of the Code of Ordinances. The property is generally located north of Sentinel Oak Road and west of Simmons Road.
