2020-272 Citizens to be heard - The City Council invites citizens to address the Council on any topic not already scheduled for a Public Hearing. 2020-275 Conduct a public hearing and consider and act upon an ordinance accepting a petition for voluntary annexation and annexing 11.013± acres out of the SA&MG RR Company Survey, Abstract No. 1048, Ellis County, Texas and more generally described in Exhibit "A" in the attached ordinance, extending the boundary limits of the city to include said territory within the City's limits, granting to all inhabitants and owners of the territory all of the rights and privileges of other citizens, and binding the inhabitants by all the acts, ordinances, and regulations of the city; adopting a service plan for the described territory; and providing an effective date (Case No. AX04-2020-095).

- 2020-276 Conduct a public hearing and consider and act upon an ordinance relating to the use and development of 224.883± acres out of the J. Smith Survey, Abstract No. 971, and R. Graham Survey Abstract No. 421, by changing the zoning from Agricultural (A) District to a Planned Development District (PD) for single-family residential uses. The property is located on the north side of Mockingbird Lane, between Walnut Grove Road and North Mockingbird Lane (approximately 2,000 feet east of the intersection of Walnut Grove Rd. and Mockingbird Lane) (Z18-2020-068).
- 2020-277 Conduct a public hearing and consider and act upon an ordinance to rezone a part of Lot 4, Block 52, of the Town of Midlothian Addition, from Residential Three (R3) District to Urban Village Planned Development District No. 130 (UVPD-130) for Professional Office uses. The property is located at 716 West Avenue G (Case No. Z20-2020-084).
- 2020-278 Conduct a public hearing to consider and act upon an ordinance relating to the use and development of 56.432± acres out of the Samuel Frederick Survey, Abstract No. 357, and the A.J.
